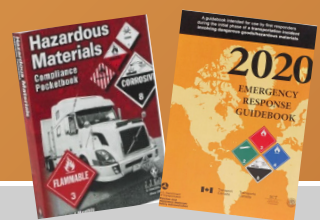

#### 177.800(c) Responsibility for Training

A carrier may not transport a hazardous material by motor vehicle unless each of its hazmat employees involved in that transportation is trained as required by this part and subpart H of part 172 of this subchapter.

This training class meets the requirements of 49 CFR Part 172.704 and 177.800(c). This is a required training for ALL hazmat employees. Mandatory testing is included. \*Certificates will be mailed at the conclusion of the seminar.
